Dear Scholarship Applicant:

The Shasta Builders' Exchange Community Fund Scholarship Program has been established as a means to support and secure education for the children of SBE members who wish to utilize the educational system as a means of obtaining goals they have set for themselves. To date the SBE Community Fund has contributed over \$60,000 to children of Exchange members.

ELIGIBILITY REQUIREMENTS: The Scholarship Program is open to the children of owners (mother/father/legal guardian) and key employees of either a **Priority** or **Total Access** SBE member who is a **contractor** or **construction supplier** firm in good standing. A written recommendation from the Exchange firm's owner must accompany applications from children of key employees. Students entering or continuing enrollment in a university, college, community college or trade school as a full-time student may re-apply for scholarship funds.

APPLICATION SUBMISSION: Applications are available in print form at the Shasta Builders' Exchange, or can be downloaded from www.shastabe.com/forms. Applications must be submitted using the "official" form provided by the Exchange. Applications submitted not using the "official" form will be discarded. Applications must be accompanied by: (1) certified transcripts from your High School/College (***please note: first year college applicants must supply H.S. transcripts as well as first semester college transcripts***), (2) High School SAT/ACT scores, and (3) a written recommendation from the firm's owner if the applicant is the child of a key employee. Applicants may resubmit updated applications for up to four years.

Applications must be received by 5:00 p.m. on Friday, May 19, 2017.

BASIS OF AWARD: Applicants will be evaluated based on academic performance (GPA, SAT/ACT), school and community extracurricular activities, and work experience. Applicants will be placed into three categories: those graduating from high school, students currently enrolled in either a two or four-year College, or students currently enrolled in either construction ROP/CTE classes or students attending a trade school.

The Scholarship Committee will review the applications received and select a group of **finalists** to undergo **personal interviews**. ***Please be advised applicants unable to attend the personal interview will be eliminated from the selection process.*** The amount of scholarship money will be determined at the time the recipients are chosen, and will be distributed directly to the recipient upon receiving proof of enrollment as a full-time student to an approved school. If proof of enrollment is not submitted to the Exchange by the time of the next year's Scholarship Program start date (March 1st), recipients forfeit their scholarship and the funds will not be awarded. **A photo and short bio must be submitted at the same time as proof of enrollment.**
